Fantastic class. I've learned more than I have in many other classes, and it's opened my eyes to many issues I never thought about regarding election administration.

I think this course was great, it was one of my favorites.

I thought the class where we attempted to come up with a situational campaign strategy had potential, and could be improved. We would need more time than 15 minutes, and some of the situation lacked context that was important to our strategy. Maybe instead of hypothetical situations, pick out real-life losing campaigns or future campaigns in the next election cycle and task groups with finding an improved or ideal campaign strategy, with the benefit of hindsight. Instead of a short 30 minute exercise, this could be an out-of-class group project requiring a slideshow, writeup, etc.

Professor Spencer and Professor Herrnson are both amazing professors alone. Together they were even better! Not

only are they extremely knowledgeable and leaders in their respective fields, but they presented all the course material in extremely engaging ways and were very accessible to students.
